We are accepting applications for the position of Area Supervisor in the Child Nutrition Department. Applicants should have at least three [3] years food service management experience. A college degree in Dietetics, Hotel/Restaurant Management, or in a related field is preferred. Multi-campus/unit supervisory experience and/or Texas Association for School Nutrition [TASN] certification is also beneficial. This is a 226-day position.

The duties of the School Child Nutrition Services Supervisor shall include, but are not limited to the following:

- Responsible for monitoring and supporting operation of assigned schools in the following areas:
- Responsible for compliance of all federal and state regulations.
- Must demonstrate and apply knowledge of all areas of the National School Lunch Program in order to communicate accurately and effectively.
- Responsible for monitoring daily food production, according to established quality standards.
- Responsible for implementation and evaluation of customer service.
- Must demonstrate and apply knowledge of operation, diagnosis and resolution of all software programs used in Child Nutrition.
- Responsible for hiring, staffing and evaluating personnel in assigned schools as well as resolving issues.
- Responsible for implementation of work schedules, labor hours and time management.
- Responsible for fiscal accountability of assigned school through established financial standards, inventory management and profit and loss.
- Must be "hands on" in supporting assigned schools.
- Responsible for assuring that all Aldine I.S.D. and Child Nutrition Department policies, practices and procedures are followed.
- Must demonstrate team work skills to support all schools and the Child Nutrition Department.

- Must serve as a liaison between school administration and office staff, cafeteria staff and the Child Nutrition office staff.
- Responsible for all other duties as assigned.

If you are interested in being considered for this position, please submit a Child Nutrition application (found on the A.I.S.D. website), a letter of interest (indicating the I.D. #) and an updated resume reflecting the qualifications stated. Letters of interest and resume *must* be returned to the **Department of Human Resources** by the close of business on **Monday, August 26, 2013.** Late applications will not be accepted.
